## **REPORTS:**

**USAGE (Part 1)**: Simon was not on line at the beginning of the meeting. Jim Howard gave an abbreviated report on the progress of planning for the USAGE. There have been one or two planning meetings. A planning meeting is scheduled for April. Jim will forded a copy of the minutes of the last planning meeting which will be attached to these minutes.
