## Minutes for the MKP Elder Court Zoom Call Monday, October 5, 2015

**Website Development:** Norman Pearl reported on the progress he and Ron have made in setting up the website. He showed the court a document which outlined several features/functions of the website. Norman presented two versions of an Elder Council Mission Statement. One was established during 2007 and the other was offered by Ron and Norman. The Court chose to stay with the 2007 mission statement: (insert mission statement here). Some Court members did not have the document that Norman was referencing. Some Young Warriors will be attending the World Elder Gathering in Hawaii (October 10-15). The Planning Team for the WEG in Hawaii have coordinated fundraising to support Young Warriors in traveling to the WEG.

Zoom Meeting with Elder Contacts: Ron Roesler reported on the phone call he had with 9 Elder Contacts. It was a dynamic call with good sharing about elder vibrancy. Someone took minutes which Ron has shared with the Court. Ron was energized by the impact of the call. He noted that men began asking questions about each other as the conversations proceeded. Some of the men on the call requested that the calls be held monthly. Ron has found that some communities/areas/centers have little to no elder activities while others are thriving with great activities. He hopes that this sharing by the Zoom calls will help stir elder vibrancy in places where it is not so robust. Ron will continue to invite all Elder Contacts to join in these phone calls.

**Ritual Elder Coordinator Report:** Rod Clay was able to be on the call for only a short time. He sent the Court his Ritual Elder Report for the month of September. Report is copied at the end of these minutes.

David Bauerly had no new information to report from the Leader Body. He will be attending the World Elder Gathering in Hawaii. He reported that at this point, Rich Tosi will be well enough to attend as well. A third leader, Ric Broniec, will also be attending the World Elder Gathering.
