Elder Development: John Lindermuth reported on two topics.

- 1. John Lindermuth and his cohorts (John deStrakosch, John Frost and Gary Parker) are offering their Ritual Elder Workshop at the USAGE in Upstate NY. They are in touch with Steve Aman, one of the Co-Chairs for USAGE 2016. They are tentatively thinking of beginning the workshop on Wednesday, September 28, and ending on Thursday afternoon, September 29. John wants to look at the workshop from 2015 WEG in Hawaii as they prepare this upcoming workshop.
- 2. John is also looking at the possibility of a Multicultural workshop/training to be presented in association with USAGE 2015. Through a survey John has found a strong interest in having a workshop as many ritual elders will be in need of completing the multicultural requirement before January 1, 2017. John is also in touch with Rick Broniec who could be one of the presenters. The workshop costs would include \$1200 for two presenters plus their travel. He is exploring the cost issues and when the workshop might be presented. Under consideration is the workshop being presented during the USAGE or perhaps after the USAGE is over. He has also been in touch with the USAGE Program co-chairs.

Rod Clay reported that he had received a phone call from Terry Jones. John Lindermuth pointed out that a program developed by Ric Stuecker and Tim Schladand, based on Ric's publication, <u>Vibrant Emeritus</u>, <u>The Elder in the Twenty-First Century</u> is also under consideration for endorsement by the MKP USA Curriculum Committee.
